

## 2023 PACIFIC BRAND AFFILIATE SALES COMPENSATION SUMMARY

Nu Skin Enterprises, Inc. (together with its affiliates, the "Company") is a global direct selling company that currently operates in almost 50 markets and sells its products through a network of Independent Brand Affiliates. In the PACIFIC region, the Company operates in 4 markets/territories<sup>1</sup>.

The purpose of this document is to provide accurate and straightforward information regarding sales compensation paid to Brand Affiliates by the Company. The table belowsets forth detailed information concerning sales compensation paid to Brand Affiliates registered in the PACIFIC markets in 2023<sup>2</sup>.

Generating sales compensation as a Brand Affiliate requires considerable time, effort, and commitment. This is not a get rich quick program and there are no guarantees of financial success.

The average number of active Brand Affiliates<sup>4</sup> each month in the PACIFIC region was 18,573. On a monthly basis, an average of approximately 2,510 Brand Affiliates, or 13.5% of the active Brand Affiliates in the PACIFIC region earned a sales compensation payment.

Common expenses may include, but are not limited to, travel, office supplies, license fees, insurance premiums, and legal or accounting fees.
